

PARTIAL RESCISSION OF “STRONG MAYOR POWERS – COUNCIL AND STAFF DIRECTION” OF MARCH 26, 2024

Subject: Strong Mayor Powers – Council and Staff Direction of March 26, 2024

WHEREAS on March 26, 2024 Mayor Groves issued a direction to Town of Caledon (“Town”) Staff and Council under Part VI.1 of the *Municipal Act* (“Direction”);

WHEREAS Clause 2 and Clause 3 of the Direction directed Town Staff to give notice of and hold a statutory public meeting for the Zoning By-laws included therein as Schedules “A1” to “A12” (“Zoning By-laws”);

WHEREAS notice of the statutory public meeting was given pursuant to section 34(13) of the *Planning Act* and in accordance with section 5 of *O. Reg 545/06*;

WHEREAS Town Staff held the statutory public meeting for the Zoning By-laws on April 25, 2024;

WHEREAS Clause 4 of the Direction directed Town Staff to comply with section 34(12) of the *Planning Act* by ensuring that sufficient information and material are made available to the public to understand generally the proposed Zoning By-laws;

WHEREAS Town Staff have complied with the requirements of section 34(12) of the *Planning Act*;

WHEREAS Town Staff have complied with clauses 2, 3, and 4 of the Direction;

WHEREAS Clause 1 the Direction directed Council to consider the passage of the Zoning By-laws at its regular meeting of April 30, 2024 under section 284.11.1 and 284.10 of the *Municipal Act*;

WHEREAS Clauses 5 to 7 of the Direction directed the Mayor and the Clerk to undertake certain actions if the Zoning By-laws were passed pursuant to section 284.11.1 of the *Municipal Act* at the regular council meeting of April 30, 2024;

WHEREAS Council did not consider the passage of the Zoning By-laws at its regular meeting of April 30, 2024;

WHEREAS the Mayor has therefore not exercised her power under section 284.11.1 of the *Municipal Act* to require a vote on the Zoning By-laws at the regular meeting of council of April 30, 2024;

WHEREAS the Mayor desires to rescind clauses 1, 5, 6, and 7 of the Direction and, for clarity, will not require a vote on the Zoning By-laws pursuant to section 284.11.1 of the *Municipal Act*.

I, ANETTE GROVES, MAYOR OF THE TOWN OF CALEDON, HEREBY DIRECT that Clauses 1, 5, 6, and 7 of the Direction are hereby rescinded and inoperative.
