

THE CORPORATION OF THE TOWN OF CALEDON
BY-LAW NO. [By-law Number Inserted by Town]

Being a by-law to amend Comprehensive Zoning By-law 2006-50, as amended,
with respect to Part Lot 25, Concession 9 (Albion) and Part Lot 26, Concession 9
(Albion),

Town of Caledon, Regional Municipality of Peel,
municipally known as 10249 Hunsden Sideroad.

WHEREAS Section 34 of the Planning Act, as amended, permits the councils of local municipalities to pass zoning by-laws for prohibiting the use of land or the erecting, locating or using of buildings or structures for or except for such purposes as may be set out in the by-law;

AND WHEREAS the Council of The Corporation of the Town of Caledon considers it desirable to pass a zoning by-law to permit the use of Part Lot 25, Concession 9 (Albion) and Part Lot 26, Concession 9 (Albion), Town of Caledon, Regional Municipality of Peel, for estate residential purposes.

NOW THEREFORE the Council of The Corporation of the Town of Caledon enacts that By-law 2006-50 as amended, being the Comprehensive Zoning By-law for the Town of Caledon, shall be and is hereby amended as follows:

1. The following is added to Table 13.1:

No person shall alter, destroy, disturb or remove any vegetation within the 10 m natural area without the approval of the Town unless deemed hazardous to human health or safety.</p>

2. Schedule "A", Zone Map [map number] of By-law 2006-50, as amended is further amended for Part Lot 25, Concession 9 (Albion) and Part Lot 26, Concession 9 (Albion), Town of Caledon, Regional Municipality of Peel, from Rural – Oak Ridges Moraine (A2-ORM) to Rural Estate – Exception AAA (RE-AAA) and from Environmental Policy Area 2 – Oak Ridges Moraine (EPA2-ORM) to Open Space – Oak Ridges Moraine (OS-ORM) in accordance with Schedule "A" attached hereto.
3. Schedule "B" S.E. Map [map number] attached hereto, is hereby added to Schedule "B", Structure Envelope (SE) Maps of By-law 2006-50, as amended, for the lands legally described as Part Lot 25, Concession 9 (Albion) and Part Lot 26, Concession 9 (Albion), Town of Caledon, Regional Municipality of Peel.
